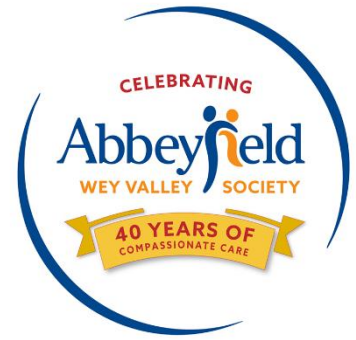


**Abbeyfield Wey Valley Society**

Terms and Conditions



## 1. Promoter

The promoter of this raffle is the **Abbeyfield Wey Valley Society**.

## 2. Eligibility

- 2.1 The raffle is open to residents of the United Kingdom aged 18 years or over.
- 2.2 Proof of age may be required.

## 3. The Raffle

- 3.1 The raffle will open on 1 April 2026 and close at midnight on 5 November 2026 (“the Closing Date”).
- 3.2 All entries received after the Closing Date will be void.
- 3.3 The raffle is a charity raffle operated in accordance with the Gambling Act 2005 and is registered with the local authority.

## 4. How to Enter

- 4.1 Tickets cost £1 each.
- 4.2 Tickets may be purchased in person at the Society’s Care Homes or at an event.
- 4.3 Each ticket has an equal chance of winning.
- 4.4 No refunds will be given once a ticket has been purchased.

## 5. Prize

- 5.1 A full list of prizes available is published on our website [www.awvs.org.uk](http://www.awvs.org.uk) or can be obtained when purchasing a ticket.
- 5.2 The prize is non-transferable and no cash alternative will be offered.
- 5.3 The Promoter reserves the right to substitute the prize with one of equal or greater value if circumstances beyond their control make this unavoidable.

## 6. Draw and Winner Selection

- 6.1 The winners will be selected at random from all valid entries.

6.2 The draw will take place on **[date]** at the Society's Central Office, adjudicated by a member of the Charity's Board.

6.3 The decision of the Promoter is final and no correspondence will be entered into.

## **7. Winner Notification**

7.1 The winner(s) will be notified within 7 days of the draw using the contact details provided at entry.

7.2 If a winner cannot be contacted or does not claim the prize within 30 days, the Promoter reserves the right to redraw the prize.

7.3 All winning entries will be posted on the Society's website.

## **8. Publicity**

8.1 By entering the raffle, winners agree to the use of their name and/or photograph for promotional purposes, unless they notify the Promoter otherwise.

## **9. Liability**

9.1 The Promoter accepts no responsibility for entries lost, delayed, damaged or incomplete due to technical or other issues.

9.2 To the fullest extent permitted by law, the Promoter shall not be liable for any loss, damage or injury arising from acceptance or use of the prize.

## **10. Data Protection**

10.1 Personal data supplied during the course of this raffle will be processed in accordance with UK data protection legislation.

10.2 Data will be used solely for the administration of the raffle and will not be shared with third parties unless required by law.

## **11. General**

11.1 The Promoter reserves the right to cancel, suspend or amend the raffle where necessary due to circumstances beyond their control.

11.2 These Terms and Conditions shall be governed by and construed in accordance with the laws of England and Wales.

11.3 By purchasing a ticket, entrants are deemed to have accepted these Terms and Conditions.
