



Appendix A: Self-assessment form

This self-assessment is completed by the Chief Executive Officer and will be reviewed and approved by the Board of Trustees at least annually.

Once approved, the Society will publish the self-assessment as part of their annual complaints performance and service improvement report on their website. The Boards response to the report must be published alongside this.

The Society, as required, have completed this self-assessment in full and supported all statements with evidence, with additional commentary as necessary.
